**Associate of Applied Science Degree**  
**Electric Power Generation Technology Certificate**

**Degree Applicants:**

Students who have first earned an AAS degree in another program, may apply to earn a second AAS degree in EPG. Approved programs for the first degree include, but are not limited to:

- Automotive Technology
- Aviation Maintenance
- CAT Dealer Service Technician Option
- Electrical Distribution Systems
- Electronics Engineering Technology
- Industrial Electricity
- Heavy Equipment Technology
- Medium/Heavy Truck Technology
- Outdoor Power and Sports Technology
- Heartland Dealers Association Option

Applicants from other degree programs, please contact the Office of Admissions.

**Certificate Applicants:**

Those who have gained fundamental mechanical, electrical, or electronic skills through other means such as industry experience or college studies may apply for the EPG certificate program.

**Applications Requirements for State Tech graduates and State Tech students:**

To be considered for Electric Power Generation Program, submit all of the items listed below to the Office of Admissions:

1. **Easy Application for Admission** - Available in the Office of Admissions.
  - List school and/or work activities on your application.
2. **State Tech Transcript** - The Office of Admissions will request this on your behalf from the Student Records Office.
 

Note: Admission into EPG is competitive – for consideration into EPG you should work to maintain a high State Tech grade point average, job readiness/work ethic score, and class attendance percentage.
3. **Test Scores** - Submit either ACT, ACCUPLACER, and/or COMPASS test scores.
  - Test scores are used for course placement and program admittance.
  - **Associate of Applied Science Degree Requirements:**

ACT	22	18	18
ACCUPLACER	116	81	81
COMPASS	66	70	81

  - Results from these tests must be less than five years old.
  - Test scores may be waived with approved transfer credit.
  - The ACCUPLACER test is offered on the State Technical College of Missouri campus for a nominal fee. To prepare for the test, visit <https://accuplacer.collegeboard.org/students/prepare-for-accuplacer>. Contact the Office of Admissions to schedule a test appointment.
  - Check [www.actstudent.org](http://www.actstudent.org) for ACT test locations, fees, and details for registering for the test. State Tech is a testing location and our test code is 5105.
4. **Bennett Mechanical Written Test** - Contact the Office of Admissions to schedule your testing appointment if you have not already taken this test.
5. Applicants may be contacted for an interview.

**Application Requirements for all others:**

1. **Application for Admission** - Available online at [www.statetechmo.edu](http://www.statetechmo.edu) (no application fee).
2. **Education Record** - Submit all that apply to you:
  - High school students will be given tentative admission based on a sixth or seventh semester transcript. An official eight-semester transcript from an accredited high school must be submitted after high school graduation and be mailed directly from your high school to the Office of Admissions. The final, original transcript must be in a sealed, unopened envelope (not faxed) and should include the date of graduation, final GPA, school seal, and signature of

school official.

OR

- Official passing high school equivalency test (HiSET or GED) score report - Missouri HiSET or GED score reports will be obtained online by the Office of Admissions. Faxed copies are not accepted. High school equivalency graduates outside of Missouri should request that the State Department of Education in the capital city of the state in which they tested send an official copy of their score report to the Office of Admissions.

OR

- A home-school transcript

OR

- Transfer Student - Official college transcript(s) with 24 or more semester credits from an accredited higher education institution. If the applicant has earned less than 24 college semester credits, submit both the official college transcript and an official high school transcript or official passing high school equivalency test (HiSET or GED) score report or home-school transcript.

3. **High School Attendance Record** form completed and signed by your high school counselor. Transfer students (students with 24 or more college semester credits from an accredited higher education institution), home school students, and students who earned high school equivalencies rather than high school diplomas do not need to submit the high school attendance record form.

4. **Test Scores** - Submit either ACT or COMPASS test scores.

- Test scores are used for course placement and program admittance.

- Results from these tests must be less than five years old.
