Practical Nursing Technology
Observation Site Suggestions**

Before job shadowing in most healthcare facilities, individuals must meet the health requirements for the staff. This usually requires individuals to:

- Present records to show they have **up-to-date vaccinations**. These vaccinations are usually the same ones required by the local school system to attend school.
- Have a **yearly tuberculosis skin test**.
 - The skin test can be obtained from the local Health Department for a nominal fee. The test also needs to be read 48 to 72 hours later at the same facility.
 - **Note:** Sometimes positive results occur without the presence of an active tuberculosis infection. If that occurs, contact your physician and follow procedures.
- Individuals need to report the date of their full-blown outbreak of Chicken Pox on their vaccination record. If they haven't had Chicken Pox, they will need to get a blood test (a "varicella titer") to see if they are already immune to Chicken Pox, and if not, they will need a varicella vaccination (a "VV vaccination"). Healthcare facilities require health workers who have not had Chicken Pox to be immunized against it.
- There may be other specific requirements at the healthcare facility you choose to complete observation hours, so expect this experience to take several weeks from start to finish.

Below are several healthcare facilities that will allow job shadowing for individuals interested in the Practical Nursing Technology program. **Individuals are not limited to the list below when completing the observation experience, but must observe a Licensed Practical Nurse.**

Other suggestions for observation include any local Long Term Care Facility, Clinic, School Nurse, Health Department, or Home Health Facility.
